## ANTI RAGGING COMMITTEE

In alignment with the mandates of the Honourable Supreme Court, the All-India Council for Technical Education (AICTE), and the Government of Madhya Pradesh, our institution maintains a zero-tolerance policy toward ragging. This criminal offense is strictly forbidden within and beyond campus boundaries.

The institution shall take decisive action against any student found engaging in ragging-related activities:

- Direct or indirect participation in ragging will result in legal consequences as per prevailing laws
- Students with prior involvement in ragging will be barred from admission
- Post-admission discovery of ragging activities will lead to immediate expulsion
- Both State and Central governments have established strict penal provisions for ragging offenses

**Objectives:** The committee serves to ensure a safe and respectful academic environment by preventing all forms of student harassment. This includes protection against verbal abuse, physical intimidation, and psychological distress, with special emphasis on safeguarding new students.

**Responsibilities:** The committee is entrusted with the following responsibilities:

1. Maintaining vigilance across the campus, particularly in areas susceptible to ragging incidents, and conducting inspections when required.
2. Conducting surprise checks in hostels and other vulnerable locations to deter ragging activities.
3. Investigating any reported or observed incidents of ragging, whether raised by faculty, students, parents, or guardians and submitting a detailed report with recommendations to the Head of the Institution for appropriate action.
4. Display anti-ragging posters on notice boards and prominent areas within the campus to spread awareness.
5. Implementing a procedure to collect affidavits from all first-year students during the admission process, affirming their commitment to refrain from ragging and to uphold the institution's policies.
