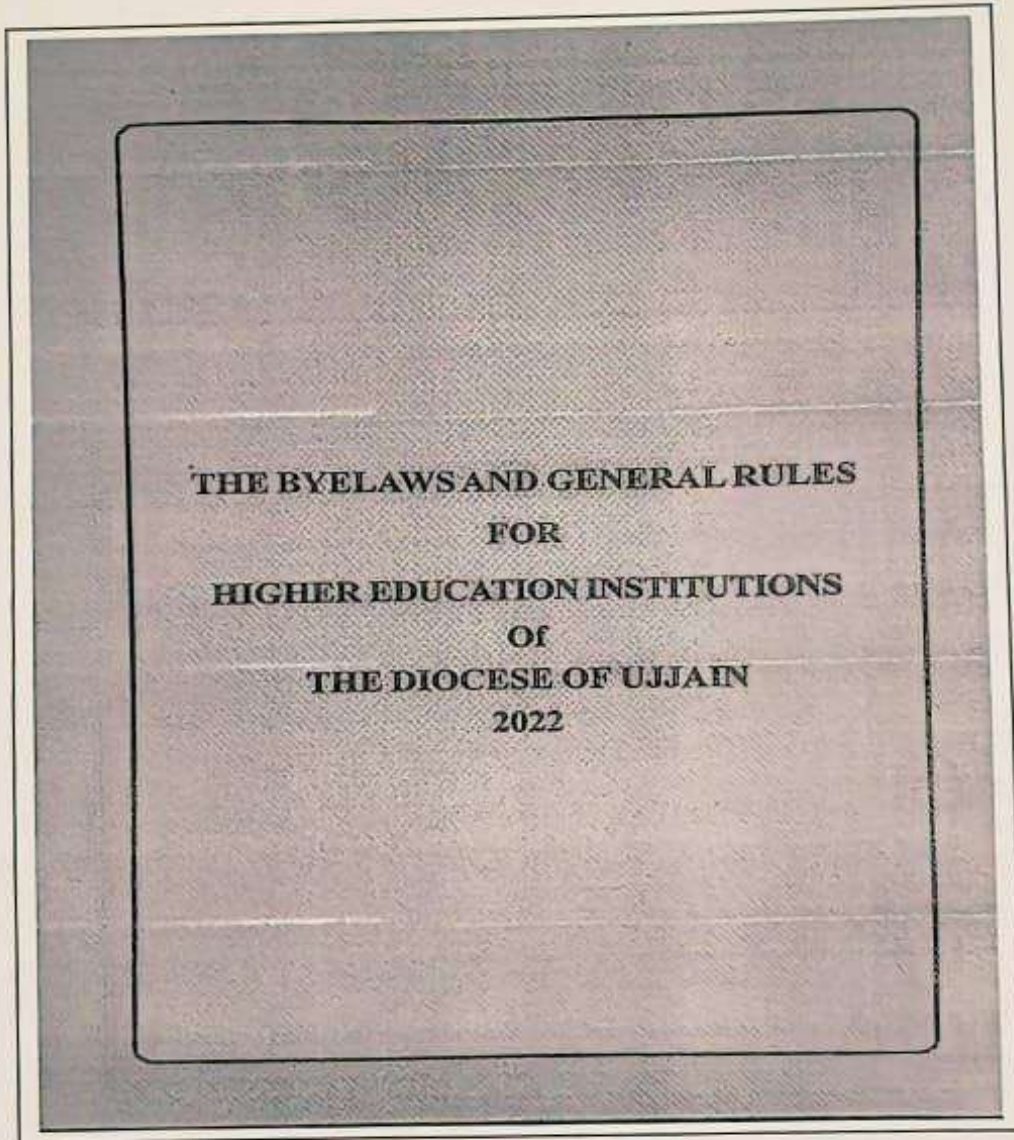

Letter of Promulgation

'The Byelaws and General Rules for Higher Education Institutions of the Diocese of Ujjain' was drafted after proper study and due consultation with all the persons and bodies concerned. It has also been discussed in detail by the Board of Directors of Higher Education Institutions of the Diocese of Ujjain in its sittings on 5th August 2021, 14th August 2021, 17th August 2021 and 6th October 2021. The observations and corrections suggested by the Board of Directors were integrated in the final draft. The Governing Body of the Diocese of Ujjain, that met on 19th November 2021, after a thorough discussion of the draft, approved the 'Byelaws' *ad experimentum* use for a period of two years. The Byelaws are formulated with the intention of specifying the vision, mission, aims and objectives of the higher education institutions run by the Diocese of Ujjain. It is to assure the Gospel and Constitutional values based excellent academic and human formation to students who should be groomed to become responsible citizens and leaders of the country in the near future. With this purpose in view, the higher education institutions in the Diocese of Ujjain give importance also to the formation and training of teachers. The Byelaws also regulate various aspects of the management and administration of the higher education institutions in the Diocese of Ujjain.

I do hereby promulgate 'The Byelaws and General Rules for the Higher Education Institutions in the Diocese of Ujjain'. These shall come into effect on 1st January 2022 and shall remain in force, for a period of two years.
